**Termination of Services** This agreement outlines the services Paul Gover provides through Green Eye Open, including pricing, payment terms, cancellation policy, and scope of services. Please read, sign, and retain a copy.

Either party may terminate this agreement with 7 days written notice. Upon client-initiated termination, unused session pack credits will be refunded on a pro-rated basis at the single-session rate of \$95 per session used. The Trainer reserves the right to immediately terminate the training relationship if the client poses a safety risk, engages in harassment or abusive behavior, or otherwise violates the spirit of this agreement.

## Payment Terms

Accepted payment methods: Cash, Zelle, and Bitcoin. Payment for single sessions is due at the time of each session. Session packs must be paid in full before the first session of the pack is conducted.

Session packs expire 90 days from the date of purchase. Unused sessions after expiration are forfeited and are not eligible for refund unless a medical exception is approved in writing by the Trainer. Packs are non-transferable.

## Cancellation & No-Show Policy

**Cancellation with 24+ hours notice:** Session may be rescheduled at no charge. If a session pack is in use, the session is credited back to the pack.

**Cancellation with less than 24 hours notice:** The full session fee (\$95) is charged, or one session is deducted from a pack. Exceptions may be granted at the Trainer's sole discretion for genuine emergencies.

**No-show (no contact, no arrival):** Full session fee is charged or one session deducted from pack. Three or more no-shows may result in termination of the training relationship at the Trainer's discretion.

**Trainer cancellations:** If Paul cancels a session with less than 24 hours notice, the session will be rescheduled at no charge to the client, or a credit will be applied.
